**DIRECTIONS:**

The grounds are located near Coulterville, IL approximately 50 miles south of St. Louis, MO. Going **East on I-64** from (St. Louis) take Interstate 64 East to Exit 23, Route 4, Mascoutah. Go South on Rt 4 to Rt 13.. Turn left (East) on Rt 13 to Coulterville. After getting into Coulterville follow directions listed below. Going **West on I-64** take Exit 50 Rt 127 South to Pinckneyville, IL. At the intersection of Rt 127 and Rt 13 turn right (West) onto Rt 13 to Coulterville. In Coulterville watch for the Pistol City Restaurant at the four way stop sign. It will be on the NW corner of the intersection of Rt 13 and Nashville Road, CR 16. Turn North on Nashville Road, crossing the railroad tracks. Proceed northward about 2 more miles to Violet Road. Turn right (E) on Violet Road. The Belclair Beagle Club is on your left (North) about 1 mile from your turn. Watch for Field Trial Signs. Please check an Illinois state map for the best routes for you to get to the site from the south thru Chester, IL. After you get into Coulterville on Rt 13 watch for the Pistol City Restaurant at the four way stop sign and follow the directions listed above to the club grounds. See Map below.
